Name Change Fees on United Airlines

- **Minor Corrections:** For simple typographical errors (e.g., correcting "Jhon" to "John"), United Airlines may charge a fee of **\$75** if the correction is made **within 24 hours** of booking.
 - **Legal Name Changes:** For name changes due to marriage, divorce, or other legal reasons, United may charge up to **\$200**, and you may also be required to pay any fare differences between the original and new ticket.
 - **Fare Difference:** Regardless of the reason, if the new itinerary is priced higher than the original, you will be charged the difference.

Types of Name Changes Allowed

United Airlines permits name corrections under the following conditions:

- **Allowed:**
 - Fixing minor spelling mistakes
 - Legal name changes with proper documentation (e.g., marriage certificate, court order)
- **Not Allowed:**
 - Changing the ticket to another person

- Altering key personal details like date of birth or gender

United does **not** allow the transfer of a ticket to someone else.

How to Request a Name Change

1. **Call Customer Service**

2. **Provide Your Booking Details**

Share your confirmation number and the correct name spelling.

3. **Submit Documentation** (if needed)

For legal name changes, you may be asked to provide documents like:

- Government-issued ID
- Marriage certificate
- Divorce decree
- Court order

4. **Pay Applicable Fees**

Be prepared to pay any name change fee and applicable fare difference.
